


Huapai grants you exclusive access to its resort-like amenities.
















Village Management

Operated by a Management Company under the ownership of the Hopper/Cabra Partnership. The Country Club takes pride in its commitment to serving its residents, and is responsible for employing a dedicated team that enhances the experience of the residents. As the village steadily grows and the resident population increases, the staff will be expanded to ensure that the evolving requirements of the residents are dutifully met.

At Country Club Huapai, residents will reside in their homes under the terms of an Occupation Right Agreement, often referred to as an ORA. This agreement grants residents the legal right to occupy their specific dwelling and outlines the obligations and responsibilities that both the resident and the operator must adhere to. The ORA, along with other documents provided by the operator, operates within the framework of the Retirement Villages Act and is officially recorded with the Register of Retirement Villages.

This registration process is in place to ensure strict compliance with the provisions outlined in the Retirement Villages Act, providing a vital layer of security to every Village resident. It guarantees that the terms of their occupancy cannot be subject to arbitrary changes, offering peace of mind to all residents. The Country Club Huapai is a registered retirement village.

What is an Occupation Right Agreement?

An Occupation Right Agreement (ORA) is the agreement the right to occupy your villa or apartment in the Country Club. An ORA is the most common form of tenure used by retirement villages in New Zealand.

What costs are included in your weekly fee?

Country Club Huapai is registered under the Retirement Villages Act 2003. The operation of retirement villages is governed by the Act and its regulations, the Code of Residents' Rights, and the Code of Practice, pave the rights for retirement village residents. When choosing to enter the Village, you will be required to sign the ORA in the presence of your solicitor, who will explain the agreement and your rights under the Act.

The weekly cost will cover:

- Property insurances (excluding your own contents, chattels and possessions)
- Maintenance of the Village buildings, common areas, and grounds
 - Use and maintenance of the facilities, including the Village van
- Alarm monitoring and security
